Supplementary Regulations

1. The Darlington & District Motor Club Ltd will organise a National B permit race meeting at Croft Circuit on Saturday 19th & Sunday 20th August 2017.
2. The Meeting will be governed by the General Regulations of the Motor Sports Association, (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions, which the organising club may issue.
3. The following MSA Permit has been issued:
National B – 102609
4. The event is open to competitors holding a National B (or higher) Race Licence and are members of Darlington & DMC, BARC, BRSCC, or are registered competitors in the Championships listed in section 5.
5. The event is a qualifying round of the following championships:
 - i) Northern Saloon & Sports Car Championship
 - ii) Petro-Canada Lubricants Porsche Club Championship with Pirelli
6. The length of the course is 2.12 miles and commences/finishes at the race circuit start/finish line. The course consists of 8 right hand and 3 left hand corners.
7. The programme for the meeting will be:

Saturday
Signing on from 7.15am in Race Administration
Scrutineering from 7.20am in the Scrutineering Bay.
Practice will commence at 09.00am with racing to follow on. Any driver not previously driven the circuit must complete 3 full laps in practice.
There will be a lunch break at a convenient time.

Sunday
Signing on at 10.00am in Race administration
Scrutineering from 10.05am in the Scrutineering Bay
Qualifying session will commence at 12.00pm with racing to follow.
8. Competitors will be identified by numbers in accordance with J.4
9. The maximum no. of starters for racing and sports racing cars up to 2000cc is 32, maximum starters for all other classes will be 40. The organisers reserve the right to amalgamate classes where necessary.
10. The entry list opens on publication of these Regulations and closes on 6th August 2017.

Entries will be accepted in receipt order.
12. Entries will be refunded as follows:
 - i) If cancellation is confirmed in writing on or before 6th August the competitor will receive a full refund.
 - ii) If cancellation is confirmed in writing and received after 6th August but at least 48 hours before the start of the event the competitor will receive a full refund less £25 administration charge unless replaced by a reserve.
13. Provisional results will be displayed at Race Administration as soon as possible after the event. Any protests should be made in accordance with C.5

15. Judges of Fact will be appointed as per G10.2 and driving standards observers as per G11.1, G11.2
16. Awards will be presented in the Pit Lane at the end of each race. There will be awards for 1st, 2nd & 3rd overall, plus championship awards.
17. Competitors are reminded that noise regulations will be STRICTLY enforced. Please ensure that your car meets the requirement.
18. Petrol is NOT available at the circuit
19. Catering facilities will be available.
20. No Trade sales may be undertaken at the event without prior written permission of the circuit owners.
21. A strict 10mph speed limit will be enforced in the Paddock and public areas. Competitors must not exceed this limit when driving in these areas. Failure to adhere to this regulation may result in exclusion from the meeting.
22. Competitors will be supplied with 4 admission tickets and 1 car pass which are included in the entry fee.
